## The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

- (b) Which has not been fully discharged.

#### Land

Any beneficial interest in land which is within the area of the relevant authority.

#### Licences

Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.

#### **Corporate Tenancies**

Any tenancy where (to your knowledge) -

- (a) The landlord is the relevant authority; and
- (b) The tenant is a body in which the relevant person has a beneficial interest.

#### (c) Securities

Any beneficial interest in securities of a body where -

- (a) That body (to your knowledge) has a place of business or land in the area of the relevant authority; and
- (b) Either -
- (i) The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
- (ii) If the share capital of that body is of more
